H. SUPERINTENDENT'S UPDATE

Mr. Saalfield reported that there was additional verbiage to the reopening policies; however, the policy committee was not able to meet before the board meeting due to the fact that two Zoom sessions cannot be held at the same time. The architect has been engaged to prepare a proposal to replace the interior fire doors per the findings of the fire inspection. The roof project has been completed, just waiting on final inspections. A family that has purchased land in Hardwick Township and is building a house on the land requested the Board allow their children to attend Blairstown Elementary while they reside in Allamucy Township while the house is under construction. Board Policy 5111 states the students may only be permitted to attend if the board approves, also the Board must decide if they wish to charge tuition. The State has made \$10 million available in grants for shared services studies, previous fund has been frozen, and this is a new source of funding that is available. The State Attorney General has made a directive to police departments to inform schools with the principal as the point of contact if a minor is a witness to trauma. There is a proposal for school districts to return to in person board meetings

in November or December; districts may only do virtual meetings if the health emergency prevents the board from meeting. The district has limited large spaces to conduct meetings.

I. PRINCIPAL'S REPORT

Dr. Ketch noted there are updates to the Gifted and Talented polices online and reports to the state. All parents must be notified of testing. Picture day is to take place October 20 through October 22. Parent teacher conferences will be moving forward either virtual or phone call. Due to the current health emergency, there will be not Halloween activities hosted by the school. The school has participated in a week of respect. The district is moving forward with implementing Link It. Nineteen students have moved from virtual learning to the hybrid in person sessions, while two students went full virtual.

K. COMMITTEE REPORTS

Finance: Mrs. Shaffer reported the receipt of the Coronavirus Relief Funds grant for the district. The district is able to deposit \$450,000 into the Maintenance Reserve Account, which will be used to fund the fire door project. There is a church that is interested in possibly leasing or purchasing the Vail School. The district is purchasing licenses to convert old laptops into Chromebooks. A special education student has moved into the district and may need an out of district tuition placement.

Security: Mr. Cook reported that the committee is looking at other opportunities to better secure the building. The committee will provide the board with an analysis at the November meeting.
