S. PUBLIC HEARING & PETITION

Mr. Shacklford has a daughter that is in Kindergarten that is currently in another district and would like to have her attend BES even though she is below the minimum age for Kindergarten. He asked the board to consider allowing his daughter to attend as a kindergarten student rather than bring her in as a preschool student.

Ms. Diego asked what kind of gym floor will be installed.

Mr. Miller asked is there going to be a waiver for preschool students to ride the bus longer than policy.

T. LEGISLATIVE UPDATE

Ms. Klein presented the following update:

The Warren County NJSBA met the previous week. The Governor created a task force to address the teacher shortage. The study will make recommendations of how to meet the challenge and come up with solutions.

There has been a lull in legislative activity. Two bills have been presented that deal with children of military families that permit them to choose their schools and jump to the front of the line. The NJSBA has raised concerns that there are not enough seats for all of the children. The bill has been taken off the agenda. There is one bill that deals with the control of certain firearms.

On October 27, the General Assembly had a voting session and gave final approval to a bill designed to assist law officials in dealing with emergencies. The Senate Education Committee considered a bill that would establish a high efficiency accelerated learning grant program to deal with the effects of the interrupted learning due to the pandemic. The Senate Transportation Committee advanced legislation to alleviate the school bus driver shortage.

Ms. Klein provided the following rundown of educational measures considered by the legislature:

Assembly voting session:

A-3835/S2426 – School Mapping Data

This amend and existing bill and uses aerial view of a school and floor plans to map building access points, locations of hazardous materials and utility shut offs and other relevant information. The American Rescue Plan has been designated for financing of this venture. The bill has passed both houses and awaits the Governor's signature.

S2912/A2131 – Police in School Polling Places

This would require plain clothes police officers at polling stations at schools. The plan will limit access by the public to the students.

S588/A4169 – Information Literacy Standards

The State Board of Education would be required to adopt information literacy standards. This address digital media and technological literacy. It also addresses themes such as facts, points of views and opinions and knowing the difference. This is heading to the Senate for a final vote.

Senate Education Committee is considering the following bills:

S3220 – High Efficiency Learning Grant Program

The bill provides high impact tutoring to mitigate effects of interrupted learning due to the pandemic. Strict guidelines will be in place to ensure good results. A grand fund would be created to finance the program.

S3172 – Path for Certification for Montessori Teachers

Teachers must hold a Montessori teaching credential, attended a four year college and meet applicable test requirements for certificate of eligibility. This will head to the Senate Floor, but the Assembly counterpart has not yet been moved.

S3203 – Non-CDL Drivers for Small School Busses

This creates a new Type S, School Bus Certificate. Ten hour training courses will be offered for these drivers. This is the latest attempt at providing flexibility in licensing bus drivers and this will head to the Senate Floor.

In November, Governor Murphy signed legislation amending the grant program to STEM teachers, established in 2019. Senate bill S2563 incentivizes public school STEM teachers to participate in the program and to ensure that nonpublic schools have access to STEM education. This expand the number of educators, increases hours of instruction and provides more opportunities for learning STEM
